Generous provisions for consultations and commenting

- WHO: Ministries, Chancellery, Provinces, Parliament, social partners, Environmental Agency, E-NGOs, Environmental Ombudsmen and interested public
- HOW: Consultation round (1): on report's content = 9 weeks Submitting stakeholders: Chamber of Commerce + ÖKOBÜRO, Umweltdachverband + VIRUS
- Consultation round (2): on revised report, with track changes per ACCC recommendations = 6 weeks via internet and email Chamber of Commerce + ÖKOBÜRO submitted. Deadline allowed timely submission of report to Secretariat

Incorporation of comments in report: Consultations NOT empty exercise

- E-NGOs raised concerns about narrowing of E-Ombudsman's competence
- "NGOs + E-Ombudsman claim PP for plans too late...not early and effective with reasonable time"; "complaints consultations too short for legislative proposals..."
- "NGOs + Chamber of Labor criticize slow article 9/3 implementation"
- "Costs complaints raised (including new costs in ELD context)"

Overall quality and comprehensiveness

- Clear, does not try to hide anything
- Covers the essentials but also focusing on developments
- Points to resources for further information
- Product of real work and expertise expenditure of capacity

Why did ÖKOBÜRO draft a Shadow Report?

- Highlight and bring to attention major problem areas in a short report (c.f. AT Report itself)
- Particularly focus on new and emerging issues
- Address things outside scope of Decision V/9b
- Acknowledge and bring attention to best practices

Final remarks

- ACCC Recommendations
- Length/Readability issue? Focus on new developments?
- Best practices in implementation reports NOT same as being best practices in terms of actual implementation
