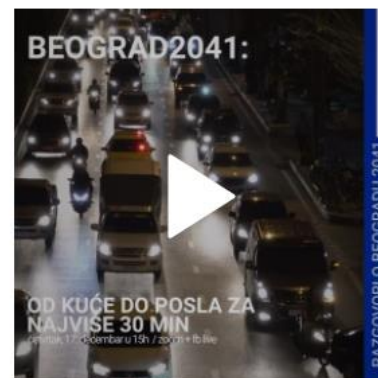




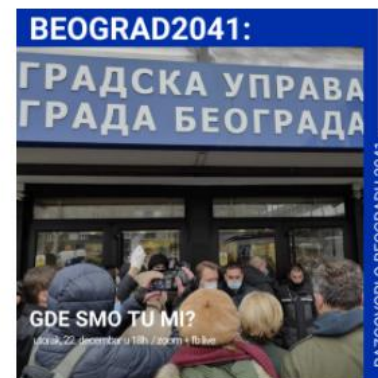

## IV PHASE: PUBLIC OPINION POLL / KEY FINDINGS

### GENERAL CONCLUSIONS:

- 54.2% BELGRADE IS DEVELOPED ACCORDING TO THE PRIVATE INTERESTS OF THE POWERFUL
- 46.8% THE CITY IS TERRITORIALY UNEVENLY DEVELOPED
- 62.4 % FEEL AS IF THEY ARE NOT INVLOVED IN THE PLANNING PROCESS
- 49% FEEL AS IF THEY ARE NOT INFORMED ABOUT CITY DEVELOPMENT AND MAJOR PROJECTS
  
- **PROBLEMS AND PRIORITIES:**
  - TRAFFIC (72.5%)
  - ENVIROMENTAL PROTECTION (44.4.%)
